

GENERAL INSTRUCTIONS

MIXING; Fill spray tank with water then pour the recommended amount of RUTEC START UP ZK on top of the water with the agitator running. Combination sprays- mix all products as recommended, fill spray tank with water, then pour START UP ZK in last with agitator running.

COMPATIBILITY-RUTEC START UP ZK is compatible with most insecticides, fungicides and herbicides. If RUTEC START UP ZK is being applied in combination, check label "Recommendations for Compatibility". If in doubt mix a small amount in a glass tumbler and observe.

STORAGE AND DISPOSAL

Store in the closed original container, in a well-ventilated area as cool as possible. Protect from frost. Do not store for prolonged periods in direct sunlight.

Triple rinse containers before disposal and add hosings to tank mix or dispose of rinsate in a disposal pit away from desirable plants, their roots and watercourses.
